**Subject: Regarding periodic inspection of affiliated institutes for making improvements in their academic standards.**

I.K.Gujral Punjab Technical University is determined to upgrade the level of technical education in the state of Punjab. In the quest of the same, University has conducted the inspection of its affiliated colleges before admissions of 2017. It has been observed that serious shortcomings are prevalent in large number of institutes in terms of the academic standards. University has already issued Show Cause notices to approximately 30 such colleges.

By keeping this endeavor continuous for next session also, University has decided to conduct the re-inspection of the institutes from October, 2017. A notification in this regard has already being issued by Registrar Office vide Notification No: PTU/Reg/N.F/1333 dated 28-06-2017 (Kindly refer to attached notification for further information). These inspections will be carried out in following phases:-

1. All the colleges to whom Show Cause Notices were served in May-July, 2017 will be immediately re-inspected by the University in the month of October/November 2017. If the colleges failed to maintain the minimum standards as per recommendations of the inspection committee, the students already admitted in session 2017-18 shall be shifted to other colleges as per choice of such admitted students and necessary action shall be initiated for de-affiliation of these colleges or closure of courses.
2. All the remaining institutes are requested to keep their records ready in all aspects.. University shall conduct the random physical inspection of the affiliated institutes likely to be started from end of month of November/December 2017. The institute which failed to maintain the minimum requisite facilities as per norms shall not be allowed for admissions in 2018-19.

The inspection teams will give one or two day prior intimation/notice before visiting the respective institutes. The inspection proforma and other details will be available on University website (cd.ptu.ac.in). For any query you may contact on following number 9478098031, 946588412, 9465884814.

With the approval of Vice Chancellor, the University is pleased to adopt the below mentioned procedure for the up-gradation of standards of technical education in Punjab

1. The University shall conduct the random physical inspections of the affiliated colleges every year. This process shall be completed every year before the month of April. The institutes which failed to maintain the minimum requisite facilities as per norms shall not be allowed for admissions in upcoming academic year.
2. The institutes (with all courses) completely put under "No Admission Zone" by the inspection committee for the academic year 2017-18 shall be re-inspected by inspection committees immediately. The admissions for 2017-18 in these institutes shall be allowed only on the basis of recommendations of the inspection committee.
3. The institutes in which partial courses are put under "No Admission Zone" by the inspection committee, are allowed for admission in those courses/institutes for session 2017-18 subject to the condition of re-inspection of the institute/courses before November, 2017. If the colleges failed to maintain the minimum standards as per recommendation of the inspection committee, the students already admitted shall be shifted to other colleges as per choice of such admitted students and necessary action shall be initiated for de-affiliation of these colleges or closure of courses.
