Sub: **Student exchange programme between IKGPTU & Concordia University of Edmonton, Canada.**

IKGPTU has signed an agreement for international student exchange on October 04, 2018 with Concordia University of Edmonton (CUE), Canada. Under this agreement both the Universities can exchange its students of BBA course for training (Copy of agreement enclosed with this letter).


As per the agreement IKGPTU is to nominate one student to Concordia University of Edmonton, Canada each year for one academic year or two students for one term in an academic year. Such students shall be termed as visiting students at CUE, Canada. Such a student shall not be required to pay any tuition fee to Concordia University of Edmonton except otherwise given in the agreement.

The student shall be nominated purely on merit basis. The eligible students (as per the agreement) who are interested in participating in this exchange programme can submit their application through their respective college on or before 31st March for commencing their term at Concordia University of Edmonton from September or on or before 31st August for term commencing from January each year till the validity of the agreement. All the clauses of agreement must be carefully read.

The application along-with required documents must be submitted to the office of Dean (Planning and External Programmes) who is designated liaison officer under this agreement.

This notification has been issued with the approval of Vice Chancellor, IKGPTU, Jalandhar.

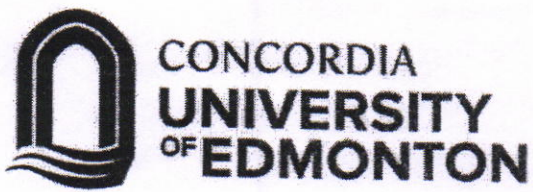

AGREEMENT FOR INTERNATIONAL STUDENT EXCHANGE
APPENDIX TO THE MEMORANDUM OF UNDERSTANDING

BETWEEN I.K.GUJRAL PUNJAB TECHNICAL UNIVERSITY

AND: CONCORDIA UNIVERSITY OF EDMONTON

Canada
("Concordia")

Collectively referred to as the "Parties"

WHEREAS:

- A. The Parties to this appendix (the "Agreement") have entered into a memorandum of understanding (the "MoU"); and
B. The Parties agree to formalize the terms for an Agreement under which it is possible for an exchange of students between the two Parties on a continuing basis (the "Exchange").

NOW THEREFORE in consideration of the above and other good and valuable consideration, the Parties agree as follows:

1. DEFINITIONS

- 1.1. In the Agreement:
a. At Concordia "Academic Year" means the period from September to April and consist of two (2) terms, one from September through December (the "Fall Term") and the other from January through April (the "Winter Term"); At IKGPTU "Academic Year" means the period from July to April consists of two terms, one from July to December and the other from January to April.
b. "Home Institution" means the institution from which a student intends to graduate and the institution in which the student is regularly enrolled;
